Application to the Texas Department of agriculture for the Fire Ambulance and service truck (FAST) fund; Authorizing the City Mayor to act as the City's Executive officer and Authorized representative in all matters pertaining to the city's participation in the Texas Community Development Block Grant.

3. Consideration, discussion and approve of Inter Local Agreement between Deport Fire Dept. and City of Deport.

Motion by Marilyn Glover; Second by Craig Folse; Motion carried: Unanimously, 5-0 Inter Local Agreement between Deport Fire Dept. and City of Deport. Agreement stating that in exchange for fire protection services for the City of Deport by the Deport Fire Department, the City of Deport is applying on behalf of the Deport VFD for a new 2021 model firetruck that is approx. \$500,000.00. The

terms of the grant are that the City of Deport will hold the title to the truck with the Deport VFD maintaining and using the truck. The first five years the grant requires that the truck stay within the Deport VFD Fire service area and in emergencies may be allowed to respond to other nearby calls for mutual aid.

Deport VFD will payback the City of Deport \$5,000.
